PURPOSE & APPROACH

Business Continuity Management Policy in CSP Abu Dhabi Terminal acts as the primary emergency management framework for the organization and established based on Risk Assessments and Business Impact Analysis with Continual Improvement in the resilience of CSP Abu Dhabi Terminal, containing its ability to Anticipate, detect, prevent, minimize, and mitigate the impact of disruptive events or incidents.

CSP ADT is committed to endure its constant terminal handling services to facilitate the continual safe Operation of ships at CSP Terminal, uninterrupted movement of Goods and supplies and flow of products and resources to country in the event of any emergency or crises through effective and efficient implementation of a Business Continuity Management system based on the set standards and guidelines by NCEMA 7000:2015 and ISO 22301:2019.

POLICY STATEMENT

The purpose CSP ADT's BCM Policy is to assist the Organization and its Management to supervise, monitor, and evaluate the implementation of BCM in any emergencies and encourage effective communications between the company and the involved parties. To accomplish the purpose and BCM principles, CSPADT will: -

1. Identify and reduces risk exposures and potential monetary losses to the company.
2. Safeguard CSPADT's Data, Competitive Information, Systems, and Infrastructure.
3. Ensure the safety of CSPADT personnel, contractors, and visitors.
4. Protect CSPADT's Physical assets.
5. Mitigate Legal liabilities.
6. Establish an enriched HSSE complied operating environment and push operations to a leaner and eco-friendly atmosphere.
7. Perform regular training and drills to improve employees' knowledge and experience in BCM.
8. Nominate a BCM team to enhance organizational resilience and informed the strategies and their role during a crisis.
9. Coordinate with Port Authority and other regulators to appropriately aligned and implement BCM in accordance with the statutory requirements.
10. Develop and continually improve BCM policy, procedures, and tools based on NCEMA 7000:2015 guidelines and following national and international standards to meet the best industry norms and market needs.
